Energy Harbor 2022 Open Enrollment Questions

1. I've never used ADP Workforce Now before. How do I get started?

Welcome! To enroll in benefits using ADP Workforce Now log in to www.workforcenow.adp.com.

Once you're in ADP Workforce Now, you'll see a pop-up window prompting you to begin Open Enrollment. You can start immediately, or you can navigate back to the main ADP landing page by clicking **REMIND ME LATER** or by clicking **HOME** in the taskbar.

On the main landing page, in a box titled **2022 OPEN ENROLLMENT DOCUMENTS**, you will find Open Enrollment presentations that walk you through your benefits options. This presentation is also on the **RESOURCES>TOOLS/REFERENCES** page under the **BENEFITS INFORMATION** section - you can select the presentation for Non-Bargaining employees or one that applies to a specific union.

You'll also see a section titled **USER GUIDES** with files that will help you navigate the Open Enrollment process. This includes: 2022 Open Enrollment Letter Navigation, Employee Self Service Quick Reference card and more.

We encourage you to open or print the files you think you'll need and use them to help as you go through the Open Enrollment process. To begin Open Enrollment go to **MYSELF > BENEFITS > ENROLLMENT**.

2. In the ADP Workforce Now Open Enrollment Portal, I can only see my benefits options at a high level. The portal does not include details around each benefit. Where do I go to find this information?

The Open Enrollment Portal does not include detailed benefits information. On the main ADP Workforce Now landing page, in a box titled **2022 OPEN ENROLLMENT DOCUMENTS**, you can find Open Enrollment presentations that walk you through your benefits options (non-bargaining). You can also visit energyharborbenefits.com for more information regarding your benefits.

We encourage you to open or print this file and use it to help you as you go through the Open Enrollment process.

3. I'm having trouble navigating through the Open Enrollment process. Can I get help with this?

No worries! There is a quick tip guide to help you. A User Guide titled "2022 Open Enrollment Letter Navigation" can be found on the **RESOURCES>TOOLS/REFERENCES** page in a Section titled **USER GUIDES**.

If your computer is having issues getting through the Open Enrollment screens, it could be the browser you're using. Please download and use one of the recommended browsers (scroll to the bottom to see a list). If you are using a recommended browser and are still experiencing issues, please call MyLife Advisors at **(855) 547-8508** for assistance.

4. I don't see my dependents information in ADP Workforce Now. How do I add it?

You'll have to add your dependents before you enroll in benefits. A User Guide titled "How to Add Dependents to ADP" can be found on the **RESOURCES>TOOLS/REFERENCES** page in a Section titled **USER GUIDES**. Be sure to select the correct relationship as there could be tax consequences.

5. What do I need to know about the Spousal Premium?

There is a one question Spousal Premium survey that asks if your spouse/domestic partner has waived medical coverage offered by their employer. Please answer yes or no. If you and your spouse will both be working for Energy Harbor in 2022, please answer no.

The spousal premium is built into the medical premium that you'll see in ADP Workforce Now when you make your selection. It will not show on the summary page at the end of your enrollment.

6. I don't see a couple of benefits that I was expecting to be automatically enrolled in?

There are certain benefits that you do not have to elect during the Open Enrollment process because you will automatically receive them in 2022. These include: Employee Assistance Program (EAP), Short Term Disability (STD), Basic Long Term Disability (LTD), Basic Employee Life Insurance, and Business Travel Insurance. These may not show up in your benefits summary when you submit your elections.

To view your benefits for 2022, navigate Home > Myself > Benefits > Enrollment > Your Benefits > View Benefits. In the top left calendar box, please select 01/01/2022.

7. In the ADP Workforce Now portal, there is an option to elect or waive Supplemental Long Term Disability. If I choose to waive this, will I still receive Basic Long Term Disability?

You are not given the option to select Basic Long Term Disability because you will automatically receive it. If you choose to waive the Supplemental Long Term Disability, you will still receive the Basic Long Term Disability benefits.

To view your benefits for 2022, navigate Home > Myself > Benefits > Enrollment > Your Benefits > View Benefits. In the top left calendar box, please select 01/01/2022.

8. What does the benefits summary show?

The benefits summary will only show you what you elected or actively waived during the Open Enrollment process. It will not show you the benefits that you are automatically enrolled in. Other than the automatic benefits, if it is not listed on the benefits summary, then it will be waived.

9. Can I double check what benefits I will receive next year, including those that I was automatically enrolled in?

To view your benefits for 2022, navigate Home > Myself > Benefits > Enrollment > Your Benefits > View Benefits. In the top left calendar box, please select 01/01/2022.

10. I accidentally chose the wrong answer to the Tobacco Usage question. Can I change this?

Please call MyLife Advisors at **(855) 547-8508** and they will change your selection for you. The MyLife Advisors are available Monday – Friday 8:00 am – 11:30 pm EST.

11. What do I do if some of my personal information is wrong in ADP Workforce Now?

If your personal information looks like it might be incorrect, please make note of it. Once Open Enrollment has ended, we'll send out a communication to notify you when you are able to make changes. This won't affect your Open Enrollment in any way.

Please note your most recent hire date is displayed in the ADP Workforce Now portal. All other relevant dates are also in the system for the purposes of calculating vacation accruals, etc., but they are not displayed.

18. If a spouse can get insurance through their employer, but we elect to put them on my insurance at Energy Harbor, what is the additional charge?

The additional charge is \$200 a month.

19. When a child /adult turns 26, does the insurance coverage end that day or the end of the year they turn 26?

Coverage ends at the end of the month of their 26th birthday.

20. Does my HSA contribution limit change if my spouse is over 65 and on Medicare as a secondary?

If the spouse is on Medicare, then the contribution can only be the single amount. It is your responsibility as the account holder to monitor contributions to your HSA to ensure that you do not go above the IRS annual limits specific to your situation.

21. Can the Energy Harbor Health Care Contribution be directly added to my HSA?

If you elect a high deductible medical plan, your contribution will be automatically contributed to your HSA. If you do not elect a high deductible medical plan, your contribution will be automatically contributed to your 401(k) plan.

22. I am not eligible for HSA due to a secondary health insurance . Do the same rules apply this year?

Yes, the same rules apply. Only certain retired military qualify for an exception, please contact Bill Thompson, Manager of Compensation & Benefits wwwthompson@energyharbor.com

23. Is my Health Equity card still good?

Yes. For 2021 claims, you have until 12/31/2021 to use the card. After 12/31/2021 you will need to use the "pay me back" option via your Health Equity account to pay for 2021 claims. You can begin using your card for 2022 claims in the 2022 plan year.

24. Is enrollment in pet insurance through Nationwide only available during open enrollment?

No, employees have the option to enroll at any time.
